Service and Payment Policy

NOTICE IS HEREBY GIVEN to all interested parties that the WIGWAM MUTUAL WATER COMPANY (herein " the Company"), incorporated under the laws of the State of Colorado, and subject to the Company's Bylaws and Rules and Regulations, and the laws of the State of Colorado, as they may be amended from time to time, has or may in the future provide domestic water service to real property, as described in Schedule A, attached hereto,

NOTICE is further given that, at the option of the Company, the Company may cease, terminate or otherwise suspend domestic water service to any property described in Schedule A, if the former Owner(s) of record of said property, have failed to pay all dues, fees, charges for usage, or other assessments, as may be assessed by the Company from time to time, OR if the former Owner(s) of record had failed to comply with any Bylaws and Rules and Regulations of the Company, pursuant to its authority. Upon passage of title of property as described in Schedule A, to a new Owner(s) of Record, without the prior Owner(s) of Record making full payment of such amount assessed by the Company, OR prior Owner(s) of record complying with Bylaws and Rules and Regulations of the Company, the Company may terminate domestic water service and/or continue to terminate domestic water service to said property until such time all dues, fees, charges for usage or other assessments are paid in full to the Company, OR Bylaws and Rules and Regulations of the Company are brought into compliance with.
